

PRIVACY DISCLAIMER

With this information we communicate, pursuant to art. 13 of the Privacy Code and the GDPR, that the personal data transmitted through navigation and use of the functions on the website www.giasitalia.it will be processed by the company GIAS ITALIA SRL as data controller (hereinafter the "Data Controller").

The personal data provided will be processed by the Data Controller on paper, computer or electronically.

1. Purpose of the processing

The personal data provided will be collected by the Data Controller for purposes strictly related to existing or future commercial relationships with GIAS ITALIA SRL.

2. Scope of data circulation

For the pursuit of the purposes described in the previous point, the personal data provided may only circulate in areas attributable to the Data Controller and may only be processed by personnel who have been assigned a specific role as data processor with adequate instructions and a commitment to confidentiality.

Personal data will be made accessible only to those who, within the Data Controller's company, need it to carry out their work duties. These subjects will be appropriately instructed to avoid loss, destruction, unauthorized access or unauthorized processing of the data.

The data may also be used by third-party companies that carry out activities related to those of the Data Controller such as, by way of example but not limited to, external persons in charge of administrative-accounting management.

3. Dissemination of data

The personal data provided will never be published, displayed or made available/consulted by subjects not previously appointed and determined.

4. Data retention

The personal data provided will be kept by the Data Controller for the period necessary to pursue the purposes referred to in point 1 above and will be automatically deleted or made anonymous within 10 years + 1 from the cessation/conclusion of the existing commercial relationships (art. 2220 Code Civil), except for needs of ascertainment, exercise or defense of the Data Controller's rights in court, which could result in longer retention of the data.

For the right to cancellation, see also point 5 below.

5. Rights of the interested party

In relation to the processing of your personal data, you can ask the Data Controller:

- Access: confirmation of the possession and processing of your personal data may be requested, as well as further clarifications regarding this information;
- Rectification: you may be asked to modify or integrate the data you provide, if inaccurate;

- Deletion: the data may be requested to be deleted if they are no longer necessary for the Data Controller's commercial purposes, in the event of revocation of consent or opposition to processing, in the event of unlawful processing, or when there is a legal obligation to delete or refer to subjects under the age of sixteen;
- The limitation: it may be requested that the data be processed only for the purposes of conservation, to the exclusion of any other processing, for the period necessary to rectify the data, in case of illicit processing for which there is opposition to cancellation, if necessary a right can be exercised in court and the data stored

by the Data Controller may be useful and, finally, in the event of opposition to the processing with an ongoing verification of the prevalence of the Data Controller's legitimate reasons;

- Opposition: it is possible to object to the processing of data at any time, unless the Data Controller has overriding legitimate reasons for the processing, such as, for example, the exercise or defense of legal proceedings.

- Portability: the Data Controller may be asked to receive their personal data or have it transmitted to another party, in a structured format, commonly used and readable by an automatic device.

Furthermore, it is possible to lodge a complaint with the Supervisory Authority, which in Italy is the Guarantor for the Protection of Personal Data.
